(“Promotion”) Terms & Conditions

1. PROMOTIONAL PRODUCTS, PROMOTIONAL PERIOD AND PARTICIPANTS

- 1.1. This promotion is applicable only to the purchase of the 'Promotional Products' (the “Promotional Products”) listed below, exclusively from Canon's Internet Store or online store (uaestore.canon-me.com), during the specified promotion period within 1st April 2024 – 31st March 2025. Vouchers will be issued by Canon Emirates LLC and can be redeemed at ART PLUS PHOTOGRAPHS PRODUCTION .
- 1.2. All participants must be 18 years of age or older and either residents of the United Arab Emirates or possess a valid delivery address within the UAE. (“Participant”).
- 1.3. All Participants are deemed to have agreed to be bound by these terms and conditions of Canon Internet Store or online store (uaestore.canon-me.com).
- 1.4. All Promotional Products must be new and genuine Canon products.
- 1.5. The scope of items to be promoted under this Promotion shall include the following:

2. HOW TO PARTICIPATE

- 2.1. To enter the Promotion, the Participant must purchase a Promotional Product on (uaestore.canon-me.com) online store of Canon Emirates LLC during the Promotional Period and receive a valid voucher code online from Canon to be eligible to redeem it from ART PLUS PHOTOGRAPHS PRODUCTION between 1st Jan 2024 – 31th March 2025.
- 2.2. The Participant will receive the voucher code upon purchasing from the promotional list provided below. The voucher code will be issued by Canon and sent by email to the Partner. To redeem the voucher code the Participant can redeem it at ART PLUS

- 2.5. Only one voucher per order will be issued to the Participant provided includes at least 1 promotional product.
- 2.6. Purchases by businesses or individuals who make bulk purchases (being more than 10 Promotional Products during the Promotional Period, will not be eligible to enter this Promotion.
