

# WORLD ENVIRONMENT DAY 2021

## 3<sup>RD</sup> - 26<sup>TH</sup> JUNE 2021

### FREE PRIZE DRAW TERMS AND CONDITIONS

#### 1. CANON AND PARTICIPANTS

- 1.1. This free prize draw is run by Canon (UK) Limited of 5 The Square, Stockley Park, Uxbridge UB11 1ET ("Canon").
- 1.2. All entrants ("Participants") must be United Kingdom residents aged 18 or over.
- 1.3. Employees of Canon, its subsidiary companies, their families, agents and other parties directly involved with this promotion and the sponsorship are not eligible to enter.
- 1.4. By entering this competition, all Participants are deemed to have agreed to be bound by these terms and conditions unless notified otherwise in writing.

#### 2. PRIZE DRAW AND HOW TO PARTICIPATE

- 2.1. The free prize draw opens at 10.00 on 3rd June 2021 and the closing date is midnight on 26th June 2021 with the draw taking place on the 28th of June 2021.
- 2.2. To be entered into the free prize draw to win one of the 5 available 12 month subscriptions for the Objectif Lune PrintShop Mail Connect solution ("Objectif Lune Solution") PLUS a 12 months free of charge technical support and one half-day remote training from Canon for the Objectif Lune Solution ("Support Service"), (together the "Prize"), entrants must visit the dedicated Canon campaign page at <https://www.canon.co.uk/environmentalday2021> and submit their contact details via an on-line form between 10.00 on 3rd June 2021 and midnight on 26th June 2021.
- 2.3. One entry per one qualifying business is permitted. To qualify as a qualifying business:
  - 2.3.1. a business needs to define their business services or one of their business services as production and supply of printed materials. It must be either a print-for-profit business or a department operating within any business that produces print, for example: central reprographics department, in-house print room, in-house print department;
  - 2.3.2. a business can be an existing Canon customer as well as a business that has no current customer relationship with Canon; and

#### 3. THE PRIZES

- 3.1. 5 winners will be randomly drawn from all valid entries received throughout the period opening at 10.00 on 3rd June 2021 and the closing date at midnight on 26th June 2021
- 3.2. Each 12 month subscription of the Objectif Lune Solution shall be issued and provided subject to its terms and conditions which are available [here](#), and each winner will be required to accept those terms and conditions during the activation process and prior to use.
- 3.3. Each 12-month free of charge Support Service shall be provided subject to the terms and conditions of Canon's services ("Contract"). Each winner will be required to sign the Contract with Canon prior to activation and use of the Objectif Lune Solution.
- 3.4. The Prize will be activated by each winner upon request to Canon and by following the steps below:
  - 3.4.1. Canon will inform the winners of the Prize
  - 3.4.2. Winners confirm they claim the Prize (within 10 working days)

3.4.5. Canon will issue the licence key to the winners

3.4.6. The 12 months subscription will start from the day the winners will receive the licence key.

3.5. Canon will contact the winners approximately a month before the end of their winning 12-month subscription of the Objectif Lune Solution and 12 months Support Service to discuss the chargeable renewal options, further plans and support available. If no other renewal options or further plans are entered into the subscription of the Objectif Lune Solution and the Support Service will be automatically deactivated and come to an end on the expiry of the winning 12 month subscription period.

3.6. The Prize is non-transferable, and no cash or credit alternatives will be substituted for the prize on offer. In the event that the Prize offered is unavailable due to circumstances beyond our control, Canon reserves the right to offer an alternative prize of equal or greater value.

#### **4. THE SELECTION**

4.1. The 5 Winners will be selected from all eligible entries using a random number generator and the winner's entry confirmed by Canon.

4.2. Canon will contact the winner as soon as practicable after the 28th June 2021 via the email address submitted in order to obtain delivery details for the Prize.

4.3. If Canon receives any rejected or unclaimed Prize from the winner within 10 working days of attempting to make contact by email, the original announced winner will forfeit their Prize.

4.4. The Prizes may be awarded to other entrants at the absolute and sole discretion of Canon UK
