A FELLOW'S ACCOUNT -

2007 CANON FELLOW DR. PETER CARDEN, MITA LABORATORY, KEIO UNIVERSITY, YOKOHAMA

I arrived in Japan on October 1st to begin my Fellowship and was warmly greeted by members of the Mita Laboratory research group at the train station and they helped me to my accommodation, which was excellent. This warmth continued throughout my stay and I felt very included in all the laboratory activities, both work and social.

As I stated in my interim report I shifted my research focus from fibre optic sensors for structural health monitoring towards interpretation of the data acquired from the sensors. This allowed me to more actively collaborate with the students and researchers in the group. A network of buildings is currently being monitored and a large database of recorded responses of the buildings is being managed by Mita Lab. About 30 members of industry are collaborating in this project and I gave a talk on November 16th at a symposium to this group in Keio University on the current state of the art of structural monitoring undertaken in Sheffield University. This was a great opportunity to share ideas and learn about the current research interests in both countries. The online real-time modal analysis of the data measured from the structures, which has been demonstrated on several projects in Sheffield University, is particularly important for dealing with large volumes of data.

My own research on the accuracy of the identifying modal parameters from output only data resulted in the paper: "Challenges in Developing Confidence Intervals on Modal Parameters Estimated for Large Civil Infrastructure with Stochastic Subspace Identification", which was submitted to the Journal of Sound and Vibration for review on March 28th. This is one of the premier journals in the field. The six months I have spent here have been very fruitful. Not only have I developed a better knowledge of the behaviour of buildings during earthquakes, but I've also made very good friends. It is with some sorrow that I leave Japan. The welcome, friendliness and great sense of comradery will last with me for a long time. I am very hopeful that there will be some form of collaboration in the future, and I would like to thank Canon for supporting me in having such a wonderful experience.



I am working as a Canon Foundation in Europe 2007 co-sponsored researcher at the European University Institute (EUI) in Florence, Italy.



CANON FOUNDATION IN EUROPE

The objective of the Foundation is the promotion of science, culture, know-how and mutual understanding between Europe and Japan.

The Canon Foundation offers Research Fellowships annually to highly qualified European and Japanese researchers. Candidates should hold a doctorate or at least a Master's degree. They are eligible during the ten-year period following the successful completion of their Ph.D or MA degree. Extensions to the ten-year rule are possible in principle in case of exceptional circumstances which should be explained in the application and supporting documents are required. Non-nationals have to have a permanent citizenship in either Europe or Japan.

The European Fellowship holders pursue a period of research in Japan whereas the Japanese Fellows do their research at host institutions in Europe. The Fellowships are awarded for periods of a minimum three months and maximum of one year.
