His host will be Prof. Kazuoki Ohara. *Architecture and Area Planning: Japanese ecomuseums*.

**Dr. Hiraku NOZAWA** at Ochanomizu University, Tokyo will go to the Dept. of Geometry and Topology at the University of Santiago de Compostela. His host will be Prof. J.A. Álvarez López. *Mathematics: Minimal model theory of Sasakian 5manifolds*.

**Mr. Daniel POCH** from Columbia University, USA will go to Waseda University. His host will be Prof. Kimiko Kono at the Dept. of Japanese Literature. *Literature: Entangled literacies; Sino-Japanese dynamics and cultural translation from the 10th to the late 19th century.* 

**Mr. Tommy SHIH** from Lund University, Sweden will go to the University of Tokyo with Prof. Robert Kneller as his host. *Politics*  and International Relations: Japanese research and innovation policy in the 21st century - investigating indirect effects of the interface between university and industry.

**Dr. Kentaro UMEKI** from Tokyo Institute of Technology where he will do research at the Dept. of Materials Science & Engineering at the Royal Institute of Technology, Stockholm, Sweden with Assoc. Prof. Weihong Yang as his host. *Environmental Studies: Numerical simulation and optimization of hightemperature agent gasification of biomass.* 

**Mr. Bas VERBERK** from the University of Leiden, the Netherlands will go to Nagasaki University with Prof. Takehiko Koji as his host. Japanese Art History: Cultural exchange between Japan and the West in the context of Japanese armour. 3 components:- Western influence on nanban armour, the Dutch influence on Japanese armour during Edo period (1600-1868) and Japanese armour in Western collections.

# EXECUTIVE COMMITTEE MEMBER VISITS RESEARCH FELLOW DR. SHINICHIRO ICHINO

"I visited Dr. Ichino and his host, Professor Kappeler at the laboratory in the German Primate Center, Göttingen. Dr. Ichino is working on "A socioecological study of ring-tailed lemurs (Lemur catta) in Madagascar". This project is based on the cumulative studies performed in the group of Professor Koyama, where Dr. Ichino obtained his PhD and worked as a post-doc for several years. He started his study in Göttingen in October 2010. Until now, he has spent his time to put together the data obtained in Japan to prepare the basis of the field work in Madagascar (planned from this April for 2 months). Professor Kappeler, who is one of the key persons of primate research in Europe, is also studying the ring-tailed lemurs in Madagascar but from a different angle than the Japanese group. By this joint project, the studies of the Japanese and German groups are going to be fused to develop new aspects.

It is very good to witness such collaborative works between Japan and Europe because it is one of the major aims of the Canon Foundation in Europe. Professor Kappeler is very happy in having Dr. Ichino in his laboratory who brought fresh atmosphere from Japan. Dr. Ichino is enjoying his life in Germany with his wife, who is a photographer and is also very interested in the nature of Madagascar." – **Dr. Seigo Shima**, February 2010

## CANON FOUNDATION IN EUROPE: 250 FELLOWSHIPS!

The Canon Foundation in Europe exceeds the figure of 250 Fellowships in 2010. In total, 261 scientists have benefitted now from overseas research, developing culturally and academically, frequently with long-lasting research collaborations as a spin-off. After the return to the home country very often reciprocal visits follow by staff and students. In this way, firm relationships are built between institutes and individuals in Europe and Japan. This is one of the objectives of the Canon Foundation in Europe and is very important to us.

To celebrate this milestone, European Alumni Chairwoman, **Dr. Helen Westgeest** (1993 Research Fellow), has initiated the idea to compile a book with essays written by Fellows on the theme of Making Research Visible to the World. **Prof. Willem van Gulik** is Board member of the Canon Foundation since its establishment in 1987 and Emeritus Professor in Material Culture studies and Art History of East Asia. On Monday 23 November 2009 he has been appointed **Commander in de Order of Oranje-Nassau** by Queen Beatrix. Mayor Henri Lenferink of Leiden adorned him with the corresponding decorations after his farewell speech.

After his studies in Chinese and Japanese, Van Gulik became curator of the department of Japan and Korea at the National Museum of Ethnology (Rijksmuseum voor Volkenkunde) in Leiden and director of the museum in 1982. In 1985 he became Extraordinary Professor in Material Culture studies and Art History of Japan and Korea, and subsequently professor in Material Culture studies and Art History of East Asia.

Van Gulik is a member of many boards, advisory councils and committees in the field of art, culture and Netherlands-Japanese relations. Among other things he is president of the *Netherlands-Japanese*  Society (Nederlands-Japanse Vereniging), the Von Siebold Council in Tokyo, and the Society for Japanese Arts.

Van Gulik frequently advises members of the Royal House. The Imperial Court in Japan also makes grateful use of his knowledge and talent. Past August he has been closely involved with the preparations for the visit of prince Akishino and princess Kiko. In 2000 he set up the Siebold House exhibition and guided the Japanese emperor, empress and Queen Beatrix on a tour there.

Professor Van Gulik is especially being praised for his dedication to society through four decennia of professorship and his many extra activities. His efforts have contributed greatly to the relations between the Netherlands and Japan. Therefore he is generally considered to be a builder of bridges.

Commander in the Order of Oranje-Nassau is one of the highest decorations in the Netherlands. Van Gulik is the first staff member of Leiden University to receive this honour. Earlier, he received the Netherlands-Japan Prize 2009 and was appointed High Officer in the Order of the Rising Sun by the Emperor of Japan.

#### CANON FOUNDATION IN EUROPE

The objective of the Foundation is the promotion of science, culture, know-how and mutual understanding between Europe and Japan.

The Canon Foundation offers Research Fellowships annually to highly qualified European and Japanese researchers. Candidates should hold a doctorate or at least a Master's degree. They are eligible during the ten-year period following the successful completion of their Ph.D or MA degree. Extensions to the ten-year rule are possible in principle in case of exceptional circumstances which should be explained in the application and supporting documents are required. Non-nationals have to have a permanent citizenship in either Europe or Japan.

The European Fellowship holders pursue a period of research in Japan whereas the Japanese Fellows do their research at host institutions in Europe. The Fellowships are awarded for periods of minimum three months and maximum one year.
