

#MYCANONCHALLENGE COMPETITION TERMS & CONDITIONS

1. General

Please read these terms and conditions carefully. The terms and conditions set out below apply to all participants submitting entries for Canon South Africa #MyCanonChallenge competition (the "Competition") conducted.

- 1. These terms and conditions are known as the "Rules".
- 2. Canon South Africa reserves the right to cancel or amend all or any parts of the Competition and/or the Rules without notice for any reason that is outside of Canon South Africa's reasonable control. Any changes to the Rules, or cancellation of the Competition, will be posted on the Canon South Africa SA Facebook page. It is the responsibility of entrants to keep themselves informed as to any changes to the Rules by visiting the Facebook Page.
- 3. In the event of any dispute regarding the Rules, the conduct or results of the Competition, or any other matter relating to a Competition, the decision of Canon South Africa shall be final and unchallengeable, and no correspondence or discussion shall be entered into, comment issued, or reason given in respect of any decision made by Canon South Africa.

2. Competition Entrants

- 1. By entering the Competition, you hereby warrant that all information submitted by you in your entry is true, accurate and complete in every respect. Canon South Africa reserves the right to verify any information contained in your entry and/or your eligibility to enter the Competition.
- The Competition is open to persons over the age of 18. Entrants may be required to provide proof of identity. Should the winner be unable to provide any of the required documentation upon request, they will be disqualified.
- 3. Please see the Prize section below for information on prizes.
- 4. Canon South Africa reserves the right in its absolute discretion to disqualify any entrant if he/she is under the age of eighteen or Canon South Africa has reasonable grounds to believe that an entrant has breached any of the Rules, any applicable law (including copyright law) or has otherwise infringed the intellectual property of any other person. Each entrant acknowledges and agrees that any failure to comply with the Rules could lead to Canon South Africa disqualifying that person, without Canon South Africa giving any reason for such disqualification or granting any opportunity for challenge.
- 5. Only images and entries shot with a Canon Product will qualify as an entry.
- 6. Canon South Africa's decision is final, and no correspondence will be entered into.
- 7. Only residents of South Africa are eligible for entry into this Competition.



8. In the event that a Prize-winner is disqualified from the Competition, Canon South Africa's authorised representative will randomly select an alternative Prize-winner from the entries received in the same manner as the original Prize-winner was selected, and such selection will be subject to these Rules.

3. Competition Entries

- 1. The Competition will be run on Instagram and is applicable to South African users who do ALL of the following:
 - Post a photo relevant to the specified monthly topic using a Canon Product;
 - Follow @canonrsa;
 - Include @canonrsa and #MyCanonChallenge in their post.
- 2. Each month, the competition opens once the challenge is released in the first week of the month. Finalists are selected on the last Friday of every month. The competition runs from 1 May 2020 to 31 December 2020.
- 3. If you enter multiple times, it will be counted as one entry.
- 4. Employees, directors, agents, contractors and consultants of Canon South Africa and all other participating companies and their immediate families, life partners, associates, or business partners do not qualify to participate or win in the Competition.

4. Prize

Each monthly Prize-winner will be able to select ONE of the following prize kits:
